Overseas Patients

We are obliged to see and treat ANY overseas patients, regardless of which country they are from, for emergency or immediately necessary treatment free of charge for up to 14 days if they are staying in our practice area. Register them as temporary residents.

For those patients that want to be treated for more than 14 days or for non-urgent or treatment that is not immediately necessary, we should register patients that are listed overleaf from an EEA country or a country with whom we have a reciprocal agreement as temporary patients.

For any patients not listed from a country overleaf, and want routine treatment or treatment over 14 days, then we should register as private and our private consultation charges apply. See overleaf for list of countries.

PATIENTS STAYING IN THE UK FOR MORE THAN SIX MONTHS SHOULD BE REGISTERED AS PERMANENT PATIENTS

PATIENTS FROM COUNTRIES LISTED BELOW CAN BE SEEN FOR TREATMENT, REGARDLESS OF THE URGENCY OR TIMEFRAME, UNDER THE NHS – REGISTER THEM AS TEMPORARY RESIDENTS

PATIENTS **WHO ARE NOT FROM COUNTRIES LISTED BELOW CAN BE SEEN FOR EMERGENCY OR IMMEDIATELY NECESSARY TREATMENT FOR UP TO 14 DAYS UNDER THE NHS. FOR ROUTINE TREATMENT OR TREATMENT OVER 14 DAYS THEY SHOULD BE TREATED AS PRIVATE PATIENTS.**
